## HSCA SENDS LETTER TO FDA URGING SAME NAMES FOR BIOSIMILAR DRUGS

HSCA Joins GPhA and Other Leading Healthcare Organizations to Raise Patient Safety Concerns about Distinguishable Names for New Category of Biologic Drugs

Washington, DC (June 30, 2015) – The Healthcare Supply Chain Association (HSCA) today joined the Generic Pharmaceutical Association (GPhA) and other leading healthcare stakeholders in sending a letter to the U.S. Food and Drug Administration (FDA) urging the agency to ensure biologics and biosimilars share the same International Nonproprietary Names (INNs) to protect patient safety. HSCA President Curtis Rooney released the following statement about the letter and the importance of naming to biosimilar safety:

"Biosimilars have the potential to increase patient access to innovative biologic treatments while also lowering costs for the entire healthcare system, but biosimilars will only be effective if they can be safely prescribed and administered. Allowing distinguishable names between biologic medicines and biosimilars could confuse patients and prescribers and lead to an increase in medical errors. It is critical that biosimilars share the same names to maximize patient safety and make the healthcare supply chain more efficient."
